Criteria for Grant Aid for a Group

1. **Aims**



The aim of the Trust is to fund education and training in rural and general life skills. This training will be available for people of any age and may be in any useful life skill but will emphasise agricultural, rural and countryside activities.

2. Eligibility

To be eligible for Grant the Trustees will need to be satisfied that the potential beneficiaries are primarily working or living in or around the close environs of Devon.

3. Level of Grant

In order to help as many people as possible grants to Groups will generally not exceed £500 or 30% of the course cost, whichever is lower at the discretion of the Trustees whose decision will be final. The amounts stated above are per application.

4. Application Procedure

Applications for the grant must be made prior to the commencement of the course.

5. Cost which may be considered

The Trustees may consider:

- Course fees
- The cost of training course including travel and necessary stays away from home to attend such courses.

If you grant is approved payment will be made direct to your bank account after your course. The Trustees will require evidence of the course costs by means of invoice and a copy of the proof of your payment along with your bank account details.

Please note repeated application, for similar courses, will not necessarily be successful.
